Self-evaluation and the new Ofsted Framework

Released in July 2010 this module reflects the changes instigated by the introduction of the new Ofsted framework and supersedes our previous Ofsted course.

It covers how Governors should work with various tools including SEF and RAISEonline and how a SIP can support and advise you. It will explain how and why Ofsted inspects schools and presents you with a fictional case study of an Ofsted inspection to explore how a school can respond to an inspection.

Admissions and Discipline

Learn about strategies and procedures that will help you appreciate both the legal and practical issues involved in pupil admissions and discipline. The course covers two topics: Admissions Procedure and Policy and Discipline and Exclusions.

Safeguarding and Promoting Child Welfare

A review on the difference between safeguarding and child protection. Covering the policies your school must have in place; how your school can ensure a safe recruitment process; what you should do in a case of suspected abuse or neglect and how to report on or respond to an allegation of abuse and the basic signs of neglect or abuse.

School Recruitment Practices

A review of the principles of performance management and an introduction to the recruitment and retention of staff. Covering three topics: Recruitment Basics; Staff Performance and Retention; Succession Planning and Headship Recruitment.

Health and Safety

An overview of Health and Safety in schools, including external trips.

Community Cohesion

How your school can assess its contribution towards community cohesion and how you can build and strengthen a cohesive community in your area.

Equality and Diversity for School Governors

Understand what Equality and Diversity means for you, for different social groups, and for schools. Identify the key legislation and guidelines relating to equality and diversity in schools, think about the best way to implement policies and plans and understand your responsibilities under the law. This course will help you to figure out the best way to handle any related situations which might arise in your school.
